Penalties (Per infraction each direction)

5 Point Penalty - Failure to demonstrate the correct lead for a minimum of 1/4 circle; jog/trot a minimum of 1/4 circle or walk for two horse lengths.

Disqualification

Evidence of lameness; fall to the ground by horse (a horse is considered to have fallen when it is on its side and all four legs are extended in the same direction); Improper equipment, evidence of abuse, exhibitor disrespect to judge, or other violation of APHA rules; Blatant striking of horse to cause forward or lateral movement with the longe whip; Horse steps over or becomes entangled in the longe line; Failure to show at all three gaits in both directions; Any time the horse becomes detached from the handler. Failure to complete trot off for soundness in three attempts. All rules apply when judges are present in the arena until all judging is complete.
